Our privacy policy

Winter Finance & Quality operates www.winterfq.nl. This page informs you of our privacy policies regarding the collection, use and disclosure of personal information we receive from users of this site.

Processing your personal data is done on the basis of the European General Data Protection Regulation (GDPR).

We think it is of great importance that personal data are handled with care. Personal data are therefore carefully processed and secured by us. We adhere to the requirements of the privacy legislation. That means, for example, that we:
